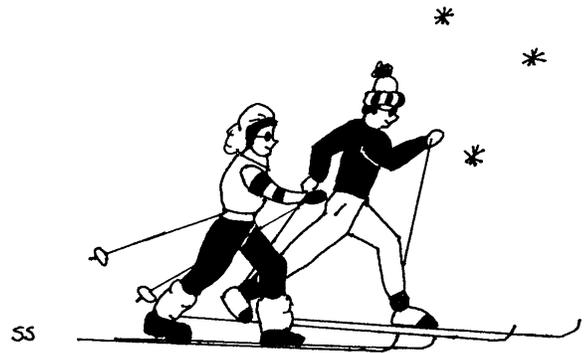




### New features:

The Crested Butte trip is full, and has a short waiting list. *The Red River and Frisco trips still have space!* Decide which trip(s) you want, and sent me your deposit. (The previous newsletter had reservation slips for each trip. Basically, I just need your name, address, home and work phones, and a check.)

### Frisco (January 16-19)

Everyone who signed up for Frisco is going on the trip. I have 8 openings left on this trip. So fill out your slip from the newsletter, follow the instructions and you too can spend the Martin Luther King weekend with us in the Frisco/Breckenridge area.

– All balances on the Frisco trip are due at the November 20 Club meeting. The balance is \$120., if you paid the regular \$100. deposit. This may be brought to the meeting or mailed to Susan Swan at the address above.

### Red River (January 30-February 1)

Everyone who signed up and paid for the Red River trip is on the trip. I still have lots of openings on the bus, so if you were thinking about going and thought that it was full ... it's not! Also for those on the trip, call around to your friends and get them involved. Fill some seats on the bus! Then fill out the slip for Red River, from your October newsletter, and send it to me with the deposit.

– Red River balance (\$90. if you paid the \$50. deposit) is due by the December 18 meeting.

It's been many years since we've had a Club trip to Red River. This is a quaint little town, with several good restaurants (and the incomparable Brett's!) and lots of little shops. We have reserved the entire Sportsmans Lodge facility. The Enchanted Forest prepared cross-country area is here, along with a downhill area and several backcountry opportunities.

*The Red River bus trip is an unusual opportunity. You get a relatively short bus ride and a chance to get familiar with an area to which you can easily return on your own. It's a great trip for novice or beginning skiers, as the Enchanted Forest cross-country ski area offers both equipment rental and lessons. This is a low-cost trip on a non-holiday weekend.*

### **Beginner Cross-Country Ski Class**

Each year the Club offers a class for beginners. It is geared toward absolute, never-ever skied wannabes, but is also appropriate for those with some experience but who feel that they need a little extra help. The class consists of two segments, a classroom session of approximately two hours, and an all-day on-the-snow session. Participants must be Club members. The cost is \$10 for the package.

The classroom session has tentatively been set for the afternoon of Saturday December 20 (subject to confirmation of reservation for a classroom location). This is the Saturday immediately after the December general meeting. This date is also contingent on there being sufficient participation at that time to justify holding a class.

At this time it is not realistic to set a definite date for the on-the-snow session, due to the possibility of another dry winter. However, we optimistically hope to have skiable snow by late January. The first tentative date to circle on your calendar is Saturday January 24.

### **Hut Trip Update**



As was indicated in the October newsletter, we have two hut trips scheduled for this coming season. Both trips require a day of travel to get to the trailhead and probably one day to get back, although delays in getting out of the backcountry could extend travel time another day.

The first item on this year's hut schedule is a New Year's trip to Betty Bear Hut. We will ski in on December 30 and spend our first night. Then, after a day of skiing in the area, we will celebrate New Year's Eve at the hut and then ski out on New Year's Day. Find out what Franz Friggenhutz means when he makes reference to what he calls "train wreck skiing." There remain three spots on this trip. Cancellations are always possible, so there could be additional spots as we near trip time.

The second trip is a two-part adventure. One group of six will ski into Fowler-Hilliard Hut and spend two nights, then ski over to Janet's Cabin. A second group, which will have left Albuquerque two days after the Fowler-Hilliard group, will ski directly in to Janet's. The two groups will then spend two nights at Janet's before skiing out together. The Fowler-Hilliard group is full, but there is no one on the waiting list. Due to a cancellation, there are now four spots left on the Janet's segment.

### **Redondo Campground Area Ski Trails Closed Through February**

The Jemez Ranger District has closed Redondo Campground and the surrounding area through February 2004. Contractors are cutting trees to thin the forest to remove hazardous trees, improve general forest health, reduce fuel loads for wildfires, and help the remaining trees fight off beetle attacks. Sam Beard and Estevan Romero were present for the beginning of the project and helped remove small cut trees from a test area. These trees were then chipped by the contractor. The finished test area looked natural and did not show obvious sign of the thinning.



## Information for Skiers

**FOOD, WATER and EQUIPMENT:** Each skier brings all of his/her own equipment; skis, boots, poles, wax, warm clothes, food, water, etc. At least one quart of water per person and extra food for delays or emergencies should be carried.

**TRANSPORTATION:** Skiers should try to car pool from the meeting point to the ski trailhead. Drivers should be reimbursed 7.5 cents per mile by each passenger in a car pool. Approximate car mileage will be listed in the trip description.

**TOUR LEADERS:** Tour leaders are volunteers who plan and lead ski tours for NMCCSC members. A tour leader has the prerogative of rejecting any person as a tour member because of equipment, ability, or any other reason. Call the leader if you have questions about the tour.

**LIABILITY:** The NMCCSC is a non-profit organization in which all activities are carried out by volunteers. The Club, Club officers, trip leaders and drivers assume no liability in connection with any Club activity. If you are concerned about accidents, either while skiing or traveling, you should obtain your own insurance policy.

**TOUR CLASSIFICATIONS:** The tour classification is an indication of the degree of difficulty of the trail and the corresponding skiing ability required to safely and enjoyably ski. Note that the length of the skiing portion of the trip is given in the trip description. The types of trails

that each class of skier may be expected to navigate are given below:

**CLASS I:** A tour with less than 1000 feet of elevation gain and less than 5 miles in length, and can be skied by novice skiers with minimal cross country experience. **Persons with no cross country skiing experience MUST take beginning lessons or must obtain the leader's permission PRIOR to joining a Class I tour.**

**CLASS II:** A tour with 1000 to 2000 feet of elevation gain and less than 10 miles in length. The trail will have gentle to moderate slopes which require the ability to stop and turn on the slopes. A Class II+ tour will have 2000 to 3000 feet of elevation gain.

**CLASS III:** A tour with greater than 3000 feet of elevation gain and greater than 10 miles in length. The trail may be steep or narrow and requires at least intermediate to advanced skiing ability.




**Hut Trips 2003-04**

This trip will give priority to long ski-intensive days, with provisions for those (the majority!) who prefer shorter days.

We will be traveling by carpool (driving Wed Feb 25), and staying in an 8-bedroom deluxe cabin next to the groomed track at Snow Mountain Ranch. Cost for food and lodging at SMR will be about \$270. per person. Driving expense and lodging on the way there will be additional.

Winter Park is at 9000' in northern Colorado, west of the Continental Divide. It usually has better (last year *much* better) snow conditions than southern Colorado. The Fraser Experimental Forest (no snowmobiles!) and two Wilderness areas are just outside town. Somewhat to the north are the Arapaho National Forest, Rocky Mountain National Park, and the Indian Peaks Wilderness. There are two large groomed areas, Snow Mountain Ranch and Devil's Thumb, each with 100 km of trails, plus some smaller groomed facilities.
